• The **Business** Correspondents (BCs) & Business Facilitators (BFs) representatives are appointed by banks to act as their agent and provide banking services in remote locations where the bank does not have a presence in order to promote financial inclusion.

Skilling India for an Inclusive Growth

- The fundamental difference in the role of the BC and BF is that BCs are permitted to carry out regular transactions for customers on behalf of the bank.
- BFs are only responsible for spreading awareness related to banking and bank's products, assisting the bank in business generation activities and recovery of bad debts. However, they do not undertake any cash transactions.

- Currently there are about 2.5 lakhs BCs providing banking services in India.
- With various Central Government initiatives like the Pradhan Mantri Jan-Dhan Yojana and RBI granting licences to several new banks with an intention to reach out to the unbanked population of India, the need for BC/BFs is increasing day by day.

- A BC/BF should be well versed with not only the banking products, but also with latest technologies like POS devices, Micro ATMs, Bio Metric devices, etc, to provide their services effectively to their customers.
- The individual is required to have good interpersonal and problem solving skills.
