

## **Invitation of Proposal for affiliation as an NSDC Training Partner**

The **National Skill Development Corporation (NSDC)** was set up as a one of its kind, **Public Private Partnership Organisation**, under the **Ministry of Skill Development and Entrepreneurship (MSDE)** with the primary mandate of catalyzing the skills landscape in India.

Launched in October 2009, it has a mandate to help catalyze the creation of sustainable, for-profit, quality skills training institutions across the country.

NSDC invites proposals from interested entities for affiliation as either a:

1. **Funded Training Partner** - for financing of projects that are commercially viable, scalable and sustainable, or;
2. **Non-Funded Training Partner** – for reputed entities with established credentials, not requiring financial assistance
